



Anschutz Campus Seed Fund Proposal Form



The Anschutz Campus Seed Fund (ACSF) was started in 2018 with the aim to support the CU Anschutz Medical Campus faculty in development and production of educational content for the Coursera platform. The goal is to ensure courses and specializations have the resources necessary for their successful creation and launch of targeted in-demand subject matter content. As of fall 2024, the seed funding request process is available for Anschutz Campus faculty.

ACSF is funded by a percentage of the total revenue generated quarterly by existing Anschutz Campus educational content on Coursera. Funding requests and grant amounts will vary with a cap

of \$50,000 per project. Two projects per calendar year is the anticipated funding capacity.

The ACSF requires that faculty complete the form below to be considered for funding. Proposal forms will be accepted on a rolling basis. To submit a proposal form, complete the template below and submit to: jaimie.henthorn@cu.edu

- Outline the content you propose to create and launch on the Coursera open platform (typically three courses). Please break the outline down into sufficient detail so that the reviewers can evaluate the courses for fit with the Coursera format, including learning objectives and/or skills to be learned.
- 2. Describe the differences between creation and implementation of Coursera content as contrasted with teaching in -person or online at the University. Include in this description, with details:
 - a) The marketability of offerings on the Coursera learning platform
 - b) The essential and necessary characteristics of instructional design on Coursera
- 3. Indicate how this funding will make possible a growth opportunity for you, your department, school or college, and for Anschutz overall. Please state:
 - a. How will your courses on Coursera expand the reach of your instruction (or the reach of this content outside of the University). Please address why your content in particular will drive that reach.
 - i. Provide specific reasoning why you think this content has the potential to reach a broad enough audience to generate revenue, and
 - ii. Indicate the positive impact this educational content launch could have on reputation.
