Dear Friends of the Center -

This year our annual report highlights our work, but it is also a celebration of partnerships. We have outstanding researchers (page 5); we have educators who teach learners from every school on our campus (page 24); we have clinical ethics teams that serve the hospitals on our campus and beyond (page 12); and we have Arts and Humanities programs that elevate the \*care\* in health care (page 17).

But tying all of these together are our partners, who enrich our research, teaching and clinical work, and who give our center its unique reach into communities in and outside of our campus.

Recently, for example, we worked with the ABPD (a group of 100 top bioethics centers) to survey centers like ours across the US and Canada. The topic was community engagement, and the results were revealing because they show just how unique our focus on partnerships is. Only six centers nationwide reported that they have a community board that represents the public and helps to shape their programs (see ours on page 33). And few approach the scale of our outreach programs; we did 35 publicly-accessible programs in 2023, reaching not just students, staff and faculty on our campus, but thousands of people from around the country and the world.

Of course, these high-quality programs would not be possible without the expertise and work of our incredible faculty and staff. But they are achieving far greater reach and impact because of our partners, supporters and friends.

So, to all of our partners, thanks for everything you do to make our center stronger, wiser, and more useful to the communities we serve.

#### **New Greenwall Trust Grant**

Trusting patient-clinician relationships should be mutual. A patient may trust or mistrust a doctor, but a doctor may also trust or mistrust a patient. The vast majority of prior research on trust in health care has focused on understanding patient trust. This project is focused on two areas that haven't been studied nearly as much: (1) clinician trust in patients, including how that can help build reciprocal patient trust in the clinician, and (2) the roles of organizational and system policies and practices on building up or tearing down mutually-trusting relationships in health care.



# New Centers for Disease Control and Prevention Contract

The Respiratory Health Division in the National Institute for Occupational Safety and Health has asked Dr. Bero and an interdisciplinary team of scholars to conduct a scoping review of the world's literature on one of the most controversial issues emerging from the pandemic. Which infection control practices are best suited to diminish indoor transmission of respiratory infections through the air? The knowledge gained from this scoping review can be used to make recommendations about best practices and to articulate a research agenda to close remaining knowledge gaps.

# Researcher Profile: Lauren H. Nicholas, PhD, MPP

Dr. Nicholas joined the Center in September of 2023. She is a health economist whose research focuses on the role of public policy in improving health and healthcare quality for the elderly. Dr. Nicholas's work uses clinical and econometric approaches to answer questions in medical and health economics, particularly for dementia, surgery and end-of-life care. ### Matt DeCamp, MD, PhD Emerging Expert on Al Ethics in Health Care with "Hat Trick"

Matthew DeCamp, MD, PhD, achieved an academic "hat trick," with articles published in *Science*, *Nature* and *Annals of Internal Medicine*, all in June and July 2023. The *Nature* article explores how new technologies on the frontier of promising large scale proteomics research are raising new privacy concerns. In *Science*, DeCamp argues that implementation of algorithms can introduce bias even if care was taken to remove bias from the data sets used in training. Finally, DeCamp takes on chatbots in *Annals of Internal Medicine*, examining how chatbot and virtual assistant characteristics such as skin color, age, perceived gender identity, body size, dialect, personality, or perceived attractiveness, could have positive or negative influences following chatbot encounters.



# **Professional Research Assistants (PRAs)**

PRAs are tasked with executing research, taking it from conceptual to realized. This often includes project management, data collection and analysis, as well as publishing research results. In their current work, PRAs are investigating the ethics of artificial intelligence in health care, trust in the physician-patient relationship, and COVID testing and treatment in communities across Colorado. In October, PRAs presented their findings at the *American Society for Bioethics and Humanities* Annual Conference in Baltimore, MD.

#### **Clinical Ethics Consultation**

**Clinical Ethics Consultations** are services provided by an individual or group in response to question from patients, families, surrogates, healthcare professionals, or other involved parties who seek to resolve uncertainty or conflict regarding value-laden concerns that emerge in health care.

**Moral Distress Rounds** are designed to promote discussion of the experience of having a sense of the right thing to do but feeling impeded from fulfilling that ethical obligation due to internal or external constraints.

#### Ambassadors Train as Liaisons for the Ethics Consult Service

The Clinical Ethics Team at CBH is currently training 11 UCHealth Ethics Ambassadors in common ethical challenges related to decision-making capacity, substitute decision-makers, safe discharge, professional integrity, non-beneficial intervention, self-directed discharge, conflict mediation, and moral distress. The 2023 cohort consists of 4 RNs, 2 Social Workers, 2 Coordinators, 2 Spiritual Care Providers, and 1 Occupational Therapist.

Occupational Therapist Stephanie Bigley, who works at University Hospital's Emergency Department explains, "Being an ethics ambassador has helped me refine so many skills; problem-solving, utilizing cognitive screens to provide objective data for MD's to use towards their capacity evaluations, advocating for patients who don't have family or social support, especially geriatric patients who are facing such fragile situations. This role is an opportunity to be part of the solution, not just bringing up a problem. Gathering our multidisciplinary team where everyone plays such a pivotal role to work together and find what might be best for a patient that day and for the long term, so they don't end up coming back to the ED."

The mission of the Ethics Ambassador Program, inspired by the Ethics Liaison Program at Children's Hospital Colorado, is to empower individuals within various clinical units and departments with fundamental ethics concepts, equipping them to proactively identify and address ethical concerns within their spheres of influence. By fostering a community of Ethics Ambassadors, we aim to create a network of knowledgeable and vigilant professionals who serve as catalysts for early recognition and resolution of ethical challenges. Through collaborative education and open dialogue, our program seeks to further enhance the ethical climate of the UCHealth system.

# "Considering Justice in an Unjust World" 24th Annual CHCO Pediatric Ethics Conference

This conference at Children's Hospital Colorado in April 2023, examined the concept of justice in healthcare and the impact of racial, ethnic, gender, and socioeconomic disparities on access to care. Through case-based discussions led by ethics faculty and healthcare leaders, the 149 participants investigated complex cases illuminating disparities and systemic barriers to equitable care, while exploring advocacy methods and enacting their moral agency to improve just delivery of pediatric health care services.

# Ethics Liason Program at Children's Hospital Colorado

The CHCO Ethics Liaison Program consists of 77 liaisons who provide a vital role in fostering compassionate, ethical care.

Ethics Liaisons train in ethical discernment, communication, decision-making approaches, conflict resolution, and addressing moral distress. Ethics Liaisons like **Chara Kurtz, RN** proactively address ethical "hotspots," preempting conflicts, facilitating open discussions while rounding, and connecting staff to helpful resources during times of moral distress. Chara stated, "We truly are a liaison between the nurse, the rest of the medical team, and the parents. You are trying to bring people together collectively to share a similar vision to best care for the patient."

With their natural curiosity and focus on bringing diverse perspectives together, Ethics Liaisons are invaluable in navigating the ethically challenging cases that are inevitable in a leading children's hospital. Their work promotes consistent, collaborative patient-centered care and supports the resiliency of the remarkable staff.

This program at Children's Hospital Colorado is a national model and served as a template for the UCHealth Ethics Ambassador Program.

# Welcome Dr. Katie Rhine New Director of the Arts and Humanities in Healthcare Program



**Kathryn Rhine, PhD**, joined CU in September of 2023 from the University of Kansas, where she spent several years establishing a global health and medical humanities curriculum. Her passion is building the infrastructure needed for the arts and humanities to flourish, especially in health care settings. She is eager to work with faculty, students, staff, and community members in interrogating what makes us human, speaking truth to power, and contextualizing our practices and processes. Rhine believes the arts and humanities are uniquely positioned to offer a skillset that enhances the delivery of healthcare--including deep listening, close observation, person-centered communication, compassion, empathy, personal growth, and much more.

#### **Current Projects and Upcoming Initiatives:**

- Continuing programming around 2024 exhibitions: <u>Raw Material: Quilts by NedRa Bonds</u> and <u>7,000 Babies: The Legacy of Justina Ford, MD</u>.
- Implementing a Delphi study that will allow the Anschutz campus community to discuss and prioritize the central learning outcomes of social justice programming, funded by a President's DEI grant.
- Assessing the impacts of arts-based educational programs on medical students' observation skills, empathy, and racial bias, funded by a Rymer Innovation Award from the CU Academy of Medical Educators.
- Planning upcoming exhibition by painter Jeffrey Kent, inspired by the story of Henrietta Lacks.

# Advocating for Children in Migration

Warren Binford, JD, Ed.M, the W.H. Lea for Justice Endowed Chair in Pediatric Law, Ethics & Policy and Director for Pediatric Law, Ethics & Policy at the Kempe Center is an international children's rights scholar and advocate.







OBODY IS ILLEGAL

Art as Advocacy, launched at the Fulginiti Pavilion in June 2023, highlighted four artistic projects that were inspired by the sworn testimonies of children arriving to the United States in 2019. The children reported being taken into custody by the U.S. government shortly after arrival and having almost all their belongings taken away. When the children's sworn declarations with their brutal details were made public, the artistic community responded with fiery indignation and determination to ensure that the children's voices would be heard.



Keynote speaker ACLU attorney **Lee Gelernt** said, "It's almost impossible to fully describe the harm," regarding children separated from their families at the border.

On September 21, 2023 CBH and the Kempe Center held a bilingual multidisciplinary symposium at the Fulginiti Pavilion that included panels focused on a variety of approaches to advocacy including arts and literature, law, medicine and behavioral health, music, and the performing arts. These discussions emphasized the moral imperative all of us have to speak out when we witness injustice. The symposium concluded with the world premiere of *Soul Echoes*, an immersive vocal and dance drama by J.E Hernandez about family separation at the border.





### Fly to Heal Mural



When asked, What did you feel when you saw the mural?, one survey respondent said, "Awe, beauty, sorrow, empowered."

The Center led the initiative to bring the first mural to the Anschutz Medical Campus. *Fly to Heal* was installed on the west wall of the Fulginiti Pavilion, and it was made possible through partnership with Colorado Area Health Education Center.

The selection committee developed an international call for submissions, received 96 proposals, and selected a local artist, Juls Mendoza.

When Mendoza and his family left Mexico, he lost a childhood filled with play, friendship, and adventure. He thus chose to create a mural depicting a spirit of courage and hope. When asked what he wanted people to take away from his mural, Mendoza replied: "healing."

We hope that this is the first of many murals to bring culturally informed, publicly accessible art to our campus, to engage students, faculty, staff, alumni, and the community in emerging issues in health care and society.







#### Public Health Ethics & Law (PHEAL)

#### Advancing Health Justice in New Collaborative

PHEAL launched in February as a joint initiative of the Center for Bioethics and Humanities and the Colorado School of Public Health. Including law within public health curricula provides future practitioners with critical tools to identify and address legal issues to advance public health. Importantly, this foundational education supplies public health students with understanding and skills to confront the structural drivers of health inequities. In June, the Public Health Ethics and Law (PHEAL) Program convened a workshop at CBH entitled "Teaching Public Health Law Outside of a Law School." The first output of the workshop was the "Centering Law in Public Health Education" commentary published in Health Affairs Forefront.

#### **Bioethics and Humanities Trail**

#### **New Specialization Offered for 4th Year Medical Students**

In 2023, the School of Medicine launched the Bioethics and Humanities Trail, one of five areas of specializations (known as trails) in the new curriculum for fourth year students.

Trail co-directors Brian Jackson and Daniel Goldberg spent most of 2022-23 designing and building the Trail. Dedicating such a substantial amount of curricular space to bioethics and humanities content is rare among U.S. medical schools and presents unique opportunities for the Center for Bioethics and Humanities. The trail covers a wide variety of fields and topics, including clinical, research, and public health ethics, as well as the history of medicine, literature and medicine, visual arts, and performing arts.

#### **Health Ethics & Humanities Certificate**



The Graduate Certificate in Health Humanities and Ethics (HEHE) offers timely courses geared towards enriching health professions students and working health professionals. Mark Kissler, MD, MS, Center Academic Leadership Council member from the School of Medicine, taught the *Foundations of Health Humanities* course in Spring 2023. The popular elective, *Pain, Paradoxes and the Human Condition*, also returned in the Spring. In Fall 2023, Daniel Goldberg, JD, PhD, taught *Introduction to Public Health Ethics*. Students continue to report high satisfaction with the Certificate and the original courses designed and delivered by Center faculty. The Certificate Program matriculates approximately eight new students each year and has a two-year completion rate of over 90 percent.

### **Policy Education & Training**

In partnership with the Farley Health Policy Center (FHPC), the Center Education team is building programs and curricula for Policy Education & Training. In 2022-23, the team designed and delivered a Core Heath Policy Education Training Curriculum. In 2023-24, the team launched the Learner-in-Residence Program that creates protocols and pathways for all policy learners with the FHPC.

# Lancet Commission Teacher Training Fellowship



The Silvers Fellowship laid the foundation for the year-long International Lancet Commission Teacher Training program on Medicine, Nazism, and the Holocaust. Administered by the Center with a committee of leading Holocaust and medicine scholars, this initiative aims to develop medical faculty to become experts on the history of medicine and the Holocaust with 15 international fellows. 


