- ❖ Tuition and fee bills are online only. Students access bills through ucdenver.edu/UCDAccess.
- ❖ A nonrefundable 2.85% service fee applies to all debit/credit card payments. There is no fee for online payments from checking or savings accounts.
- ❖ After financial aid has been applied to your bill, any excess funds are refunded to you through direct deposit into your bank account, or a paper check mailed to your mailing address listed in the UCD Access Portal. Funds remaining from the Parent PLUS loan may be refunded to you or to the parent depending on what your parent selected on the Parent PLUS loan application.
- ❖ The refund process for direct deposit can take approximately 3 to 5 business days from the time that a credit balance is created on the student's account. Paper check refunds are processed weekly on Tuesdays and Thursdays and are mailed to the mailing address in the UCD Access Portal.
- The auto-debit/auto-withdrawal for students enrolled in a payment plan will occur on the next business day if the 20th of the month falls on a weekend or holiday.
- Dates listed above are subject to change.
